EM-CING-085-121218 - New Cingular Wireless PCS, LLC notice of intent to install a temporary cellular telephone facility for use at town owned property located at 375 Fan Hill Road, Monroe, Connecticut.

Dear Attorney Chiocchio:

The Connecticut Siting Council (Council) is in receipt of your request dated April 17, 2018, for an additional extension of time for the installation of the above-referenced temporary facility. Due to the 2015 withdrawal of Docket No. 457 for a permanent facility at 30 Cobblers Hill Court, the consent of the Town of Monroe to extend the installation of the existing temporary facility at this site, and the continuing discussions with the Town for a permanent facility at a nearby Town-owned location, the Council hereby extends the installation of the existing temporary facility to June 30, 2019. This extension is granted with the understanding that the Council will be notified should New Cingular Wireless PCS, LLC decide to decommission the existing temporary facility prior to June 30, 2019.

This decision is under the exclusive jurisdiction of the Council. Any additional change to this temporary facility will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-73. Such notice shall include all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65.



Dear Executive Director Bachman:

On December 19, 2012, the Council acknowledged use of a temporary cellular telephone facility in the above-referenced regulatory filing submitted on behalf of New Cingular Wireless PCS, LLC ("AT&T") and has since granted several extensions to AT&T. The AT&T cell on wheels ("COW") deployment at 375 Fan Hill Road, Monroe, which began in December 2012 in response to the Sandy Hook tragedy, remains in-place and continues to assist with critical communication needs of the Newtown and Monroe communities.

As you may recall, in our extension request dated April 18, 2017, we advised that AT&T and the Town of Monroe started discussions for a permanent facility at the 275 Fan Hill Road Townowned property to replace the COW. Over the last year, AT&T and the Town of Monroe have met several times to coordinate on the location of a permanent facility. As a result of these meetings, the Town identified another Town-owned parcel in the vicinity of the 275 Fan Hill Road property for the siting of AT&T's permanent facility. AT&T continues to work with the Town with the Town to develop a plan for a permanent facility to present to the Town Council.

At this time, we are seeking a further extension of **EM-CING-085-121218** for one year through June 30, 2019 so that critical communication services can be maintained as the plans for the permanent facility are developed in coordination with the Town. Please note that no changes to the COW are proposed. Accordingly, we respectfully request on AT&T's behalf such additional time to maintain the COW and your acknowledgment to do so on the Council's behalf.
