The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on August 3, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the filing. With reference to the attached email from the Council dated June 20, 2018 requests for exempt modifications require an original and two copies, in addition to an electronic copy, for processing.

The above referenced request was submitted with one original and only one copy of the filing.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Centerline Communications provide another copy of the above referenced request on or before August 20, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to August 20, 2018.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
