RE: **TS-DISH-086-190524** – Gamma Purchasing LLC (a/k/a Dish Network) request for an order to approve tower sharing at an existing telecommunications facility located at 1334 Route 85, Montville, Connecticut.

Dear Mr. MacDonald:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on May 24, 2019.

According to Section 16-50j-90 of the Regulations of Connecticut State Agencies, "no tower share application shall be approved until a complete application containing all information deemed relevant by the Council has been filed. Relevant information shall at a minimum include that listed in Section 16-50j-89 of the Regulations of Connecticut State Agencies..."

Staff has reviewed this tower share request for completeness and has identified a deficiency in the Structural Analysis Report provided with the request. The Structural Analysis Report provided is dated May 23, 2019. The Council had received a request for exempt modification from AT&T for the same facility on March 11, 2019. The above-referenced request for exempt modification does not include AT&T's approved equipment. Please see AT&T's exempt modification filing for this facility, which may be found on the Council's website under the Decisions page in Montville under the filing number EM-CING-086-190311 or by following the link:

Therefore, the tower share request is incomplete at this time. The Council recommends that Centerline Communications provide an updated Structural Analysis Report for the facility that includes proposed and approved equipment by AT&T and other entities that are located at this facility on or before July 5, 2019. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to July 5, 2019. Please provide an electronic version and one hard copy of the Structural Analysis Report for the incomplete request to be rendered complete and processed.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
