- Perform structural modifications in accordance with the structural analysis report prepared by Paul J. Ford and Co. dated September 15, 2014 and stamped-dated September 18, 2014 by Joseph P. Jacobs;
- Remove antennas and associated equipment at the 117-foot and 100-foot levels of the tower as specified in the September 18, 2014 structural analysis;
- Within 45 days following completion of the equipment installation, Sprint shall provide documentation that its installation complied with the recommendations of the Structural Engineer;
- Any deviation from the proposed modification as specified in this notice and supporting materials with the Council shall render this acknowledgement invalid;
- Any material changes to this modification as proposed shall require the filing of a new notice with the Council;


