RE: EM-VER-089-181221 - Cellco Partnership d/b/a Verizon Wireless notice of intent to modify an existing telecommunications facility located at 167 Coccomo Circle, New Britain, Connecticut.

Dear Mr. Barbadora:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on December 21, 2018. On December 27, 2018, the Council issued a letter (enclosed) stating that the above referenced request for exempt modification was incomplete because the Mount Analysis (MA) provided with the request showed a failing percentage structure rating and the modifications recommended were not referenced in the Structural Analysis Report. The Council recommended that Crown Castle provide an updated Mount Analysis Report that shows a passing structure rating no greater than 100% and an updated Structural Analysis Report referencing the proposed modifications on or before February 8, 2019.

On January 17, 2019, the Council received a MA with a passing percentage structure rating (42.9%) and no recommended modifications to the mount. However, the introductory paragraph on page 3 of the revised MA refers to the mount type as a "12-foot CSOTF sector frame". This is also indicated in Table 1 under Mount Details and in Table 4 of the MA. This is inconsistent with the Structural Analysis Report, the Construction Drawings and previously approved requests for exempt modification which all indicate an existing platform mount.

Therefore, the exempt modification request remains incomplete at this time. The Council recommends that Crown Castle provide a passing Mount Analysis that is consistent with the Structural Analysis Report and the Construction Drawings or an updated Structural Analysis Report and Construction Drawings accounting for any required antenna mount modifications on or before March 4, 2019. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to March 4, 2019.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
