On April 24, 2015, the Siting Council acknowledged receipt of Cellco's notice of intent to modify its telecommunications facility at 115 North Mountain Road in New Britain, Connecticut. The modifications involved the replacement of certain antennas and installation of remote radio heads and fiber optic cable.

As a condition of the acknowledgement, Cellco was required to provide the Council with a letter stating that Cellco's facility modifications complied with the recommendations referenced in the February 27, 2015 Structural Analysis Report. 
We are providing this "Tower Modification Certification" with regard to the structural components at the above referenced project.

The following are the basis for substantiating compliance with the tower modification documents prepared by Paul J. Ford and Company (PJF Project Number: 37515-0774.001.7805):

- Review of the Paul J. Ford and Company Structural Analysis dated 02/27/2015.
- Field observations by Centek Engineering personnel on 09/06/2015 of the completed modifications which determined all modifications were installed in general compliance with the recommendations of the structural analysis report prepared by Paul J. Ford and Company on 02/27/2015.

The modification design prepared by Paul J. Ford and Company demonstrates the tower will not exceed 100 percent of the post construction structural rating. The work under this Contract has been reviewed and found, to the Engineer's best knowledge, information and belief, to be completed in general compliance with the documents referenced above.
