Dear Mr. Murshteyn:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on March 23, 2018. On April 10, 2018, the Council issued a letter (enclosed) stating that your filing was incomplete because the site plan sheet number C501- existing antenna plan references "ATC did not analyze antenna mount to determine adequate structural capacity for any lessee loading." The Council requested that Centerline Communications provide a mount structural analysis that is stamped and signed by a professional engineer duly licensed in the State of Connecticut, and if applicable, an updated Structural Analysis Report accounting for any required antenna mount modification.

On June 22, 2018, the Council received a Structural Opinion Letter stamped and signed by a Professional Engineer duly licensed in the State of Connecticut stating the engineer's opinion – "The Final Configuration loading reflects a small increase to the Existing Configuration loading." and "In order to this assessment to be considered valid, the proposed dish must be installed as close as possible to the horizontal rail." However, the Council's April 10, 2018 correspondence to you required a mount structural analysis.

Therefore, the exempt modification filing remains incomplete at this time. The Council recommends that Centerline Communications provide a full mount structural analysis stamped and signed by a professional engineer duly licensed in the State of Connecticut, and if applicable, an updated Structural Analysis Report accounting for any required antenna mount modification by August 5, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to August 5, 2018.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).

Dear Mr. Murshteyn:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on March 27, 2018.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a discrepancy. The site plan sheet number C501- existing antenna plan references "ATC did not analyze antenna mount to determine adequate structural capacity for any lessee loading." The final antenna plan makes no reference to antenna mount. There is no mount structural analysis provided with the exempt modification filing; therefore, it is unclear whether additional reinforcements would be required for the antenna mount, which would alter the proposed loading on the structure and require an updated structural analysis report.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Centerline Communications provide a mount structural analysis that is stamped and signed by a professional engineer duly licensed in the State of Connecticut, and if applicable, an updated Structural Analysis Report accounting for any required antenna mount modifications on or before May 8, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 8, 2018.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
