PETITION NO. 1440 - Cellco Partnership d/b/a Verizon Wireless Declaratory Ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the installation of a wireless telecommunications facility and associated equipment on an extension of the support structure above the top of an existing billboard located on a commercial property at 115 Peat Meadow Road, New Haven, Connecticut. **Request for Extension of Construction Time.**

Dear Attorney Baldwin:

The Connecticut Siting Council (Council) is in receipt of your request for an extension of construction time for the above-referenced Declaratory Ruling in Petition No. 1440, dated October 30, 2024.

Please be advised that under Condition No. 6 of the Declaratory Ruling, the deadline for completion of construction of the facility expired on May 7, 2024. Verizon did not submit a request for an extension of construction time or a notice of completion of construction in accordance with Condition Nos. 4, 5 and 6 of the Council's Declaratory Ruling in Petition No. 1440.

Therefore, the request for an extension of construction time for the Declaratory Ruling in Petition No. 1440 is moot. In its October 30, 2024 correspondence to Verizon, the Council recommended that Verizon either *submit a request to amend the Declaratory Ruling in Petition No. 1440* or provide notice of completion of construction of the facility approved in Petition No. 1440 as required by Condition No. 6 of the Council's Declaratory Ruling on or before November 13, 2024.

As noted in your October 30, 2024 correspondence, the Council declares the above-referenced request for an exempt modification at the facility approved by the Council's Declaratory Ruling in Petition No. 1440 to no longer be pending before this agency.
