The Council acknowledged the above referenced T-Mobile notice of exempt modification on September 29, 2014.


The Council imposed the following conditions in its acknowledgment:

- Within 45 days following completion of the equipment installation, T-Mobile shall provide documentation that its installation complied with the recommendations of the Structural Engineer.

To the best of my information, knowledge and belief, the Special Inspections required for this project, and itemized in the *Statement of Special Inspections* submitted for permit, have been performed and all discovered discrepancies have been reported and resolved.

Representatives of Hudson Design Group LLC performed inspections during the construction of the AT&T telecommunications facility at the above-referenced address. The Final Inspection had been conducted on April 29, 2015.

Comments: Based on my knowledge, information and belief the completed construction substantially conforms to the approved plans, Connecticut State Building Code, Structural Standards for Steel Antenna Towers and Antenna Supporting Structures (ANSI/TIA/EIA-222-F), the equipment manufacturer's installation guidelines, and the following:

1. Final L700 Contract Documents dated October 27, 2014, prepared by Hudson Design Group LLC, entitled "Chartercom".
2. Structural Analysis for antennas mounted on the Self Support Tower dated October 24, 2014 prepared by Semaan Engineering Solutions.

All deviations from the approved plans do not endanger the intended occupancy of the facility and equipment substitutions are approved as equivalent to the original specifications. Construction has been satisfactorily completed.
