RE: **EM-VER-093-231012 (temp)**- Cellco Partnership d/b/a Verizon Wireless notice of intent to install two temporary telecommunications facilities located at 150 Yale Avenue and 40 Central Avenue, New Haven, Connecticut. **Yale/Harvard Football Game.**

Dear Attorney Baldwin:

The Connecticut Siting Council (Council) hereby acknowledges your notice to install two temporary telecommunications facilities at 150 Yale Avenue and 40 Central Avenue, New Haven, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies, to provide wireless services during the Yale/Harvard Football Game, an event of statewide significance with the following conditions:

1. Approval of any changes be delegated to Council staff;
2. RF access restriction and caution signage shall be installed at the sites in compliance with FCC guidance; and
3. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable

The proposed facilities are to be developed as specified here and, in your notice, dated October 10, 2023. The facilities are in compliance with the exception criteria in Section 16-50j-72 (d) of the Regulations of Connecticut State Agencies for temporary cellular service for events of statewide significance. These temporary facilities have also been carefully modeled to ensure that radio frequency emissions are conservatively below State and federal standards applicable to the frequencies to be used on these towers.

This decision is under the exclusive jurisdiction of the Council. Any additional change to these temporary facilities will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-73. Such notice shall include all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65.
