
Dear Ms. Bachman:

On September 10, 2018, the Siting Council acknowledged receipt of Cellco’s notice of intent to modify its existing telecommunications facility at 4 Elkington Farm Road in New Milford, Connecticut. Cellco’s modifications involved the replacement of antennas and remote radio heads.

As a condition of its approval, Cellco was required to provide the Council with a letter stating that it had complied with the recommendations made in the August 4, 2018 Structural Analysis Report and February 23, 2018 Tower Modification Drawings, which were attached to the EM-VER-096-180821 filing. Attached is an Engineering Letter of Compliance verifying that Cellco’s facility modifications were completed in accordance with these recommendations.

The following are the basis for substantiating compliance with the tower modification documents prepared by On-Air Engineering, LLC:

- Review of American Tower's Structural Analysis dated 8/4/2018;
- Review of American Tower's Tower Modification Drawings dated 2/23/2018;
- Review of APT's Mount Certification letter and Mount Reinforcement Design dated 9/19/2018; and
- Field Observations by APT personnel on 7/30/2019 of the completed modifications which determined all modifications were installed in general compliance with the recommendations of the aforementioned structural analysis.

The structural analysis prepared by American Tower demonstrates the tower will not exceed 100 percent of the post construction structural rating.
