Dear Cullen Morgan:

The Connecticut Siting Council (Council) received a notice of completion of construction for the above-referenced facility on June 18, 2024. Thank you for providing this information.

The Council approved the above referenced request for exempt modification in a Decision Letter dated May 30, 2024 (enclosed) with the following condition:

1. Within 45 days following completion of equipment installation, T-Mobile shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Mount Analysis;

The completion notice does not contain documentation certified by a Professional Engineer that T-Mobile's installation is in compliance with the Mount Analysis mentioned above.

Therefore, the completion notice is not in compliance with the conditions of approval at this time.

The Council recommends that T-Mobile provide the above referenced documentation on or before July 16, 2024. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to July 16, 2024.
