On November 25, 2019, the Siting Council acknowledged receipt of Cellco’s notice of intent to modify its existing telecommunications facility at 227 Boombridge Road in North Stonington, Connecticut. Cellco’s modifications involved the replacement of antennas and installation of remote radio heads on the existing tower. Construction of these modifications is now complete.

As a condition of its approval, Cellco was required to provide the Council with a letter stating that it had complied with the recommendations made in the October 22, 2019 Mount Analysis Report, which was attached to the EM-VER-102-191025 filing.

Nexius Solutions Inc. is providing this “**Notice of Completion**” regard to the wireless telecommunications facility installation project at the above referenced site.

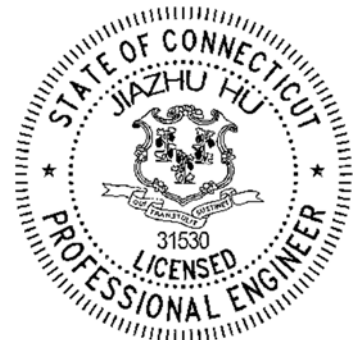
The following are the basis for substantiating compliance with the Construction Drawings prepared by Nexius Solutions Inc. Installation complies with the
