Dear Ms. Bachman:

This letter and enclosures are respectfully submitted on behalf of New Cingular Wireless PCS, LLC d/b/a AT&T ("AT&T") in response to your January 25, 2021 correspondence regarding AT&T's exempt modification EM-CING-020-191015 at 719 George Washington Turnpike, Burlington, CT ("AT&T's Burlington Exempt Modification") and the list of AT&T's exempt modifications that accompanied your correspondence.

Regarding AT&T's Burlington Exempt Modification, due to the structural integrity discrepancies connected to the facilities of AT&T, Verizon and T-Mobile, AT&T did not commence construction of its proposed upgrade. AT&T's vendor is coordinating with the other carriers' and the tower owner to determine the structural modifications needed and will resubmit AT&T's exempt modification with the updated structural information. AT&T apologizes for any inconvenience caused by its failure to request a timely exempt modification extension with this information.

With respect to AT&T's exempt modifications included with your January 25, 2020 correspondence, please find enclosed a spreadsheet listing these exempt modifications along with the status of construction for each. For the construction completed sites in the attached list, AT&T advised that it complied with all construction conditions of approval. AT&T will resubmit any exempt modification in the attached list that expired.

Finally, AT&T noted that it will re-visit its processes and procedures to ensure that going forward, required notifications are timely submitted.
