RE: **TS-VER-109-230106** – Cellco Partnership d/b/a Verizon Wireless request for an order to approve tower sharing at an existing telecommunications facility located at 954 Norwich Road, Plainfield, Connecticut.

Dear Katie Adams:

At a public meeting held on April 13, 2023, the Connecticut Siting Council (Council) ruled that the shared use of this existing tower site is technically, legally, environmentally, and economically feasible and meets public safety concerns, and therefore, in compliance with General Statutes § 16-50aa, the Council has ordered the shared use of this facility to avoid the unnecessary proliferation of tower structures with the following conditions:

- 1. Approval of any changes be delegated to Council staff;
- 2. Prior to the commencement of construction, Verizon Wireless shall provide a rigorous cumulative far-field radio frequency analysis for the facility that accounts for all entities on the tower, a 6-foot tall person at ground level and the actual antenna pattern for the proposed modifications to the facility with a cumulative %MPE at or below 100%;
- 3. The proposed antennas and antenna mount modifications shall be installed in accordance with the Mount Analysis prepared by Power of Design Group, dated November 7, 2022 and signed and stamped by Jason Cheronis;
- 4. Within 45 days following completion of equipment installation, Verizon Wireless shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Mount Analysis;
- 5. RF access restriction and caution signage shall be installed at the site in compliance with FCC guidance;
- 6. Any deviation from the proposed installation as specified in the original tower share request and supporting materials with the Council shall render this decision invalid;
- 7. Any material changes to the proposed installation as specified in the original tower share request and supporting materials filed with the Council shall require an explicit request for modification to the Council pursuant to Connecticut General Statutes § 16-50aa, including all relevant information regarding the proposed change with cumulative worst-case modeling of radio

frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65;

- 8. The Council shall be notified in writing at least two weeks prior to the commencement of site construction activities:
- 9. Not less than 45 days after completion of the proposed installation, the Council shall be notified in writing that the installation has been completed;
- 10. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable;
- 11. Any nonfunctioning antenna and associated antenna mounting equipment, or other equipment at this facility owned and operated by Verizon Wireless shall be removed within 60 days of the date the antenna or equipment ceased to function;
- 12. The validity of this action shall expire one year from the date of this letter; and
- 13. Verizon Wireless may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and applies only to this request for tower sharing dated December 28, 2022 and additional information received on March 27, 2023. This facility has been carefully modeled to ensure that radio frequency emissions are conservatively below state and federal standards applicable to the frequencies now used on this tower. Any deviation from the approved tower sharing request is enforceable under the provisions of Connecticut General Statutes § 16-50u.

The proposed shared use is to be implemented as specified in your letter dated December 28, 2022 and additional information received on March 27, 2023, including the placement of all necessary equipment and shelters within the tower compound.

Please be advised that the validity of this action shall expire one year from the date of this letter.
