The Connecticut Siting Council (Council) is in receipt of your email correspondence of July 16, 2018 submitted in response to the Council's July 11, 2018 notification of an incomplete request for exempt modification with regard to the above-referenced matter.

The statement that the structural analysis loading is inclusive of the mount modifications partially satisfies the Council's request. However, the correspondence does not address the 12 new 2.0 inch mount pipes that were not included in the "proposed carriers final configuration" table on page 4 of the May 31, 2018 Structural Analysis Report. The Council recommends that SBA provide an updated structural analysis report referencing 12 new 2.0 inch mount pipes on or before August 16, 2018. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to August 16, 2018. This second notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
