To the best of my information, knowledge and belief, the Special Inspections required by Chapter 17 for the project have been performed and all discovered discrepancies have been reported and resolved.

Representatives of Hudson Design Group LLC performed the Final Inspections after the construction of the telecommunications facility at the above-referenced address. The Final Inspection was performed on May 24, 2017.

Based on my knowledge, information and belief the wireless installation substantially conforms to the approved plans, IBC 2012 with 2016 CT State Building Code Amendments, Structural Standards for Antenna Supporting Structures and Antennas (ANSI/TIA-222-G), and the following:
