RE: **EM-EVER-118-221130e** – The Connecticut Light and Power Company d/b/a Eversource Energy notice of intent to modify an existing energy facility located at Prospect Street, Ridgefield, Connecticut.

Dear Kathleen Shanley:

The Connecticut Siting Council (Council) hereby acknowledges your notice to modify this existing energy facility, pursuant to Section 16-50j-57 of the Regulations of Connecticut State Agencies with the following conditions:

1. Any deviation from the proposed modification as specified in this notice and supporting materials with the Council shall render this acknowledgement invalid;
2. Any material changes to this modification as proposed shall require the filing of a new notice with the Council;
3. Not less than 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
4. The validity of this action shall expire one year from the date of this letter; and
5. Eversource may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The proposed modifications are to be implemented as specified here and in your notice dated November 30, 2022. The modifications are in compliance with the exception criteria in Section 16-50j-57 of the Regulations of Connecticut State Agencies for a one for one facility replacement.

This decision is under the exclusive jurisdiction of the Council. Please be advised that the validity of this action shall expire one year from the date of this letter. Any additional change to this facility will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-57.
