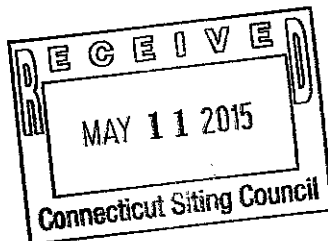

On February 25, 2014, the Siting Council acknowledged receipt of Cellco's notice of intent to modify its telecommunications facility at 225 Grist Mill Road in Simsbury, Connecticut. The modifications involved the replacement of certain antennas and the installation of remote radio heads and a new fiber optic antenna cable.

As a condition of the acknowledgement, Cellco was required to provide the Council with a letter stating that the modifications referenced in the structural report were completed. 
We are providing this "Existing Telecommunications Facility Tower Certification Letter" with regard to the antenna upgrade by Verizon Wireless at the above referenced project.

The following are the basis for substantiating compliance with the FDH Engineering structural analysis report (FDH Project No. 13SFTJ1400) dated November 1, 2013:

- Review of the FDH structural analysis report dated 11/01/2013.
- Field observations by Centek personnel of the coax, diplexer and RRH installation on 05/04/2015 which determined all coax lines, diplexers and RRH's were installed in general compliance with the recommendations of the structural analysis report prepared by FDH Engineering on 11/01/2013.

The structural analysis prepared by FDH Engineering demonstrates the tower will not exceed 100 percent of the post construction structural rating. The work under this Contract has been reviewed and found, to the Engineer's best knowledge, information and belief, to be completed in general compliance with the documents referenced above. This certification is not a review of the adequacy or effectiveness of the referenced structural analysis.
