Dear Attorney Bachman:

The Connecticut Light and Power Company dba Eversource Energy ("Eversource") received acknowledgement from the Connecticut Siting Council ("Council") on May 30, 2023 to its Notice that Eversource's proposed modifications at the existing Southington Substation at 315 Bellview Avenue in Southington would comply with the exception criteria outlined in Section 16-50j-57(a) of the Regulations of Connecticut State Agencies. In its acknowledgement, the Council included conditions regarding the proposed work, including the following;

 The requestor may file a request for an extension of time beyond the one-year deadline, provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The extension is required due to engineering delays and project material delays. Eversource hereby requests that the one-year deadline to complete the Project be extended from May 30, 2024 to May 30, 2025.
