- New Mount Modification

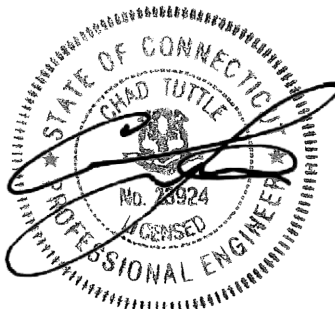
The quantities and types of antennas and associated equipment from the photographs are in compliance, therefore, it is our opinion that the antennas and associated equipment were properly installed.
