RE: TS-DISH-132-220323 - Dish Wireless, LLC request for an order to approve tower sharing at an existing telecommunications facility located at 151 Sand Hill Road, South Windsor, Connecticut.

Dear Mr. Stouffer:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on March 23, 2022.

According to Section 16-50j-90 of the Regulations of Connecticut State Agencies, "no tower share application shall be approved until a complete application containing all information deemed relevant by the Council has been filed. Relevant information shall at a minimum include that listed in Section 16-50j-89 of the Regulations of Connecticut State Agencies..."

Staff has reviewed this tower share request for completeness and has identified a deficiency in the Mount Analysis (MA) Report and the Radio Frequency Emissions Analysis (RF) Report provided with the filing. The MA Report provided is prepared by B+T Group and dated March 21, 2022 and the RF Report is prepared by EBI Consulting and dated February 14, 2022. The MA and RF reports indicate that Dish intends to mount its proposed antennas at the 150-foot level of the tower. This is inconsistent with the rest of the filing which indicate that Dish intends to mount its proposed antennas at the 102-foot level of the tower.

Therefore, the tower share request is incomplete at this time. The Council recommends that SBA Communications Corporation provide an updated MA and RF Report for the facility that is consistent with the rest of the filing or a revised tower share request that consistently shows the mounting height of the proposed antenna on or before May 11, 2022. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 11, 2022. Please provide an electronic version and one hard copy of the requested information for the incomplete tower share filing to be rendered complete and processed. Please include the Council's tower share identification number referenced above with the submittal.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
