On June 5, 2014, the Siting Council acknowledged receipt of Cellco's notice of intent to modify its telecommunications facility at 69 Guinea Road in Stamford, Connecticut. The modifications involved the replacement of certain antennas and the installation of remote radio heads and a fiber optic antenna cable.

As a condition of that acknowledgement, Cellco was required to provide the Council with a letter stating that (1) the tower shall be reinforced according to the structural report submitted; and (2) Cellco's installation shall comply with the recommendations of the structural analysis. Attached is a Professional Engineer's Certification Letter certifying that the reinforcement of the tower has been completed and Cellco's installation complies with the recommendations of the structural report submitted. All construction associated with these modifications has now been completed.

We are providing this "Tower Modification Certification" with regard to the structural components at the above referenced project.

The following are the basis for substantiating compliance with the tower modification documents prepared by Paul J. Ford and Company (PJF Group Project Number: 37513-2318 BP):

- □ Review of the Paul J. Ford and Company Structural Analysis dated 03/25/2014.
- □ Review of the Paul F. Ford and Company Modification Drawings T-1 and S-1 thru S-6 dated 03/25/2014.
- Review of the Sinnott Gering and Schimitt Towers Inc. Modification Inspection Report dated 08/13/2014.
- □ Field observations by Centek Engineering personnel on 06/30/2015 of the completed modifications which determined all modifications were installed in general compliance with the recommendations of the structural analysis report prepared by Paul J. Ford and Company on 03/25/2014.

The modification design prepared by Paul J. Ford and Company demonstrates the tower will not exceed 100 percent of the post construction structural rating. The work under this Contract has been reviewed and found, to the Engineer's best knowledge, information and belief, to be completed in general compliance with the documents referenced above. This certification is not a review of the adequacy or effectiveness of the modification/reinforcement solution.
