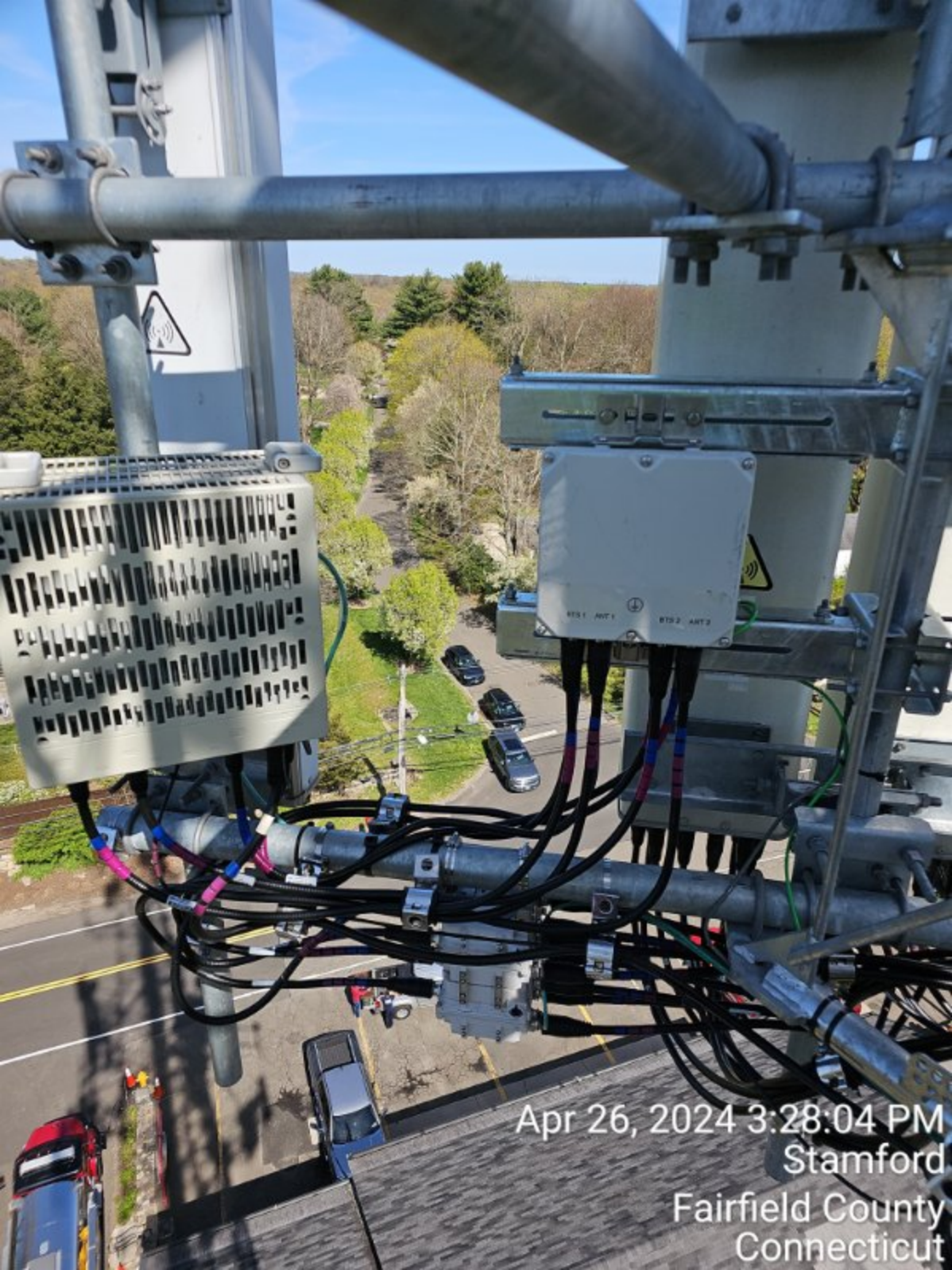
1. Final Construction Drawings dated 01/03/24 by Centerline Communications.
