RE: TS-DISH-137-211105 - Dish Wireless LLC request for an order to approve tower sharing at an existing telecommunications facility located at 166 Pawcatuck Avenue, Stonington, Connecticut.

Dear Mr. Hoogasian:

The Connecticut Siting Council (Council) received the tower share request for the above-referenced facility on November 5, 2021.

According to Section 16-50j-90 of the Regulations of Connecticut State Agencies, “no tower share application shall be approved until a complete application containing all information deemed relevant by the Council has been filed. Relevant information shall at a minimum include that listed in Section 16-50j-89 of the Regulations of Connecticut State Agencies...”

Staff has reviewed this tower share request for completeness and has identified the following deficiencies:

1. The Construction Drawings (CD) prepared by B+T Group and dated August 2, 2021, and provided with the tower share request is not stamped and signed by a Professional Engineer Licensed in the State of Connecticut;
2. The tower share request lacks documentation of the original facility approval (i.e. Council Docket No. 399) and any conditions of such approval.

Therefore, the tower share request is incomplete at this time. The Council recommends that NB+C, LLC provide a CD that is stamped and signed by a Professional Engineer Licensed in the State of Connecticut, documentation showing the original facility approval with conditions, if any, or correspondence with the municipality stating that there are no records of the original facility approval and a property card for the underlying parcel, on or before January 7, 2022. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to January 7, 2022. **Please provide an electronic version and one hard copy of the requested information for the incomplete tower share filing to be rendered complete and processed. Please include the Council’s tower share identification number referenced above with the submittal.**

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
