To the building official,

Infinigy has conducted a post construction review of the site referenced above. Infinigy has prepared the drawings for the aforementioned site and as such, we have conducted a final site review for the sole purpose of verifying that the installation was completed in accordance with the site plans.

Based on our review of the signed and sealed construction documents for this site issued by Infinigy (Revision C, 02/01/2022), and the as-built drawings, RFDS, Mount Analysis by Maser Consulting Connecticut (dated 01/19/2022) and post construction photographs provided by the contractor, it is our opinion that the site was built in general conformance with the site plans as prepared by Infinigy.

Additionally, the proposed modifications including the placement of all necessary equipment and shelters within the tower compound are implemented as specified here and in the notice dated May 9, 2022. The modifications are in compliance with the exception criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies as changes to an existing facility site that would not increase tower height, extend the boundaries of the tower site by any dimension, increase noise levels at the tower site boundary by six decibels or more, and increase the total radio frequencies electromagnetic radiation power density measured at the tower site boundary to or above the standards adopted by the Federal Communications Commission pursuant to Section 704 of the Telecommunications Act of 1996 and by the state Department of Energy and Environmental Protection pursuant to Connecticut General Statutes § 22a-162. This facility has also been carefully modeled to ensure that radio frequency emissions are conservatively below state and federal standards applicable to the frequencies now used on this tower.
