Dear Ms. Nowak:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on April 3, 2019.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the Structural Analysis Report (SA) dated March 14, 2019, the Mount Analysis (MA) dated March 29, 2019 and the Construction Drawings (CD) last revised March 25, 2019. The documents referenced above are not consistent with the Council's Petition No. 1100 declaratory ruling and condition No. 1 of the Council's Decision and Order in Docket No. 385 which states "Panel antennas shall be installed in an exterior, flush mount configuration".

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Centerline Communications either provide a SA, MA and CD that are in compliance with the Council's Petition No. 1100 declaratory ruling and Docket No. 385 condition of approval on or before May 10, 2019 or submit a motion to reopen Docket No. 385 to modify the flush mount condition. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to May 10, 2019. Please provide an electronic version and one hard copy of the required documents for the incomplete request to be rendered complete and processed.

This notice of incompletion shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 21⁻ of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
