The Connecticut Light and Power Company dba Eversource Energy ("Eversource") received acknowledgement from the Connecticut Siting Council ("Council") on December 6, 2021, of its Notice that Eversource's proposed modifications at the existing Bunker Hill Substation at 332 Clough in Waterbury would comply with the exception criteria outlined in Section 16-50j-57(a) of the Regulations of Connecticut State Agencies. On October 12. 2022, a project extension was granted to December 6, 2023. In its acknowledgement, the Council indicated that the extension was granted with the understanding that the Council will be notified should Eversource Energy need additional time to submit a notice of completion.

Due to project delays, Eversource requires additional time to complete the Project. Eversource hereby requests that the one-year deadline to complete the Project be extended to December 6, 2024. Our apologies for the late notice on this request.
