The Connecticut Siting Council (Council) hereby denies your request to modify the above-referenced existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies.

This exempt modification request was submitted to the Council on March 8, 2022. Council staff reviewed this request for completeness and had identified a deficiency that was more fully described in a notice of incompleteness letter to the requesting entity dated March 31, 2022 (attached) and recommended that Northeast Site Solutions confirm that the subject exempt modification request is not duplicative of the March 9, 2022 Crown Castle filing, on or before April 13, 2022. To date the Council has not received the requested information.

Thus, the proposed modification is not in compliance with the exemption criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies and is hereby denied.

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on March 8, 2022.

On March 9, 2022, the Council received a notice from Crown Castle of intent to modify the above-referenced facility on behalf of Verizon Wireless. The two requests propose the installation of the same equipment; however, the Crown Castle request included a more recently dated Mount Analysis with mount modifications and associated mount modification drawings and updated construction drawings.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Northeast Site Solutions confirm that the subject exempt modification request is not duplicative of the March 9, 2022 Crown Castle filing, on or before April 13, 2022. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to April 13, 2022. **Please provide an electronic version and one hard copy of the requested information for the incomplete exempt modification to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal.**

This notice of incompleteness shall have the effect of tolling the Federal Communications Commission (FCC) 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
