RE: **TS-DISH-152-220711** – Dish Wireless, LLC request for an order to approve tower sharing at an existing telecommunications facility located at 85 Miner Lane, Waterford, Connecticut. **Request for Project Change.**

Dear Ryan Burgdorfer:

The Connecticut Siting Council (Council) is in receipt of the correspondence dated September 18, 2023 regarding a project change for the above-referenced tower share request approved by the Council on August 5, 2022.

Pursuant to Condition No. 1 of the Council's August 5, 2022 tower share approval, the request to change the equipment mounting height from 177-feet above ground level (agl) to 174-feet agl due to the unavailability of the approved height is hereby approved with the following conditions:

1. Dish shall provide a copy of a Structural Analysis referencing the current Connecticut State Building Code and including all installed and proposed equipment including that of Dish, the Town of Waterford and all other entities; and
2. Dish shall provide a Radio Frequency Analysis including a rigorous cumulative far-field analysis for all entities located on the tower that accounts for a 6-foot tall person and the actual antenna pattern for the proposed modifications to the facility with a cumulative %MPE at or below 100%,

This approval applies only to the project change in the correspondence dated September 18, 2023.

Please be advised that deviations from the standards established by the Council in the tower share approval are enforceable under the provisions of Connecticut General Statutes §16-50u.
