Dear Tristen Cantelli:

The Connecticut Siting Council (Council) received a notice of completion of construction for the above-referenced facility on November 14, 2023. Thank you for providing this information.

The Council approved the above referenced request for exempt modification in a Decision Letter dated May 8, 2023 (enclosed) with the following conditions:

1. Prior to AT&T antenna installation, structural modifications shall be performed in accordance with the Structural Analysis prepared by TEP Northeast dated March 10, 2023 and stamped and signed by Daniel Hamm;
2. Within 45 days following completion of equipment installation, AT&T shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Mount Analysis and Structural Analysis.

The completion notice does not contain documentation certified by a Professional Engineer that AT&T's installation is in compliance with the Structural Analysis mentioned above.

Therefore, the completion notice is not in compliance with the conditions of approval at this time.

The Council recommends that AT&T provide the above referenced documentation on or before December 17, 2023. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to December 17, 2023.

RE: **EM-ATT-155-230412** – AT&T notice of intent to modify an existing telecommunications facility located at 2523 Albany Avenue, West Hartford, Connecticut.

Dear Hollis Redding:

The Connecticut Siting Council (Council) hereby acknowledges your notice to modify this existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies with the following conditions:

1. Prior to AT&T antenna installation, antenna mount modifications shall be performed in accordance with the Mount Analysis prepared by TEP Northeast dated March 10, 2023 and stamped and signed by Daniel Hamm;
2. Prior to AT&T antenna installation, structural modifications shall be performed in accordance with the Structural Analysis prepared by TEP Northeast dated March 10, 2023 and stamped and signed by Daniel Hamm;
3. Within 45 days following completion of equipment installation, AT&T shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Mount Analysis and Structural Analysis;
4. RF access restriction and caution signage shall be installed at the site in compliance with FCC guidance;
5. Any deviation from the proposed modification as specified in this notice and supporting materials submitted to the Council shall render this acknowledgement invalid;
6. Any material changes to this modification as proposed shall require the filing of a new notice with the Council;
7. The Council shall be notified in writing at least two weeks prior to the commencement of site construction activities;
8. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed **along with a representative photograph of the facility modification**;

9. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable;
10. Any nonfunctioning antenna and associated antenna mounting equipment, or other equipment at this facility owned and operated by AT&T shall be removed within 60 days of the date the antenna or equipment ceased to function;
11. The validity of this action shall expire one year from the date of this letter; and
12. AT&T may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The proposed modifications including the placement of all necessary equipment and shelters within the tower compound are to be implemented as specified here and in your notice dated April 11, 2023. The modifications are in compliance with the exception criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies as changes to an existing facility site that would not increase tower height, extend the boundaries of the tower site by any dimension, increase noise levels at the tower site boundary by six decibels or more, and increase the total radio frequencies electromagnetic radiation power density measured at the tower site boundary to or above the standards adopted by the Federal Communications Commission pursuant to Section 704 of the Telecommunications Act of 1996 and by the state Department of Energy and Environmental Protection pursuant to Connecticut General Statutes § 22a-162. This facility has also been carefully modeled to ensure that radio frequency emissions are conservatively below state and federal standards applicable to the frequencies now used on this tower.

This decision is under the exclusive jurisdiction of the Council. Please be advised that the validity of this action shall expire one year from the date of this letter. Any additional change to this facility will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-73. Such notice shall include all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65. Thank you for your attention and cooperation.
