RE: **EM-AT&T-155A-220217** – AT&T notice of intent to modify an existing telecommunications facility located at 29 South Main Street, West Hartford, Connecticut.

Dear Ms. Davis:

The Connecticut Siting Council (Council) hereby denies your request to modify the above-referenced existing telecommunications facility, pursuant to Section 16-50j-73 of the Regulations of Connecticut State Agencies.

This exempt modification request was submitted to the Council on February 17, 2022. Council staff reviewed this request for completeness and had identified a deficiency that was more fully described in a notice of incompleteness letter to the requesting entity dated March 14, 2022 (attached) and recommended that Crown Castle provide a rigorous far-field analysis taking into account the actual antenna pattern and accounting for a 6-foot person on the roof of the parking garage with a cumulative %MPE at or below 100%, on or before April 11, 2022. To date the Council has not received the requested information.

Thus, the proposed modification is not in compliance with the exemption criteria in Section 16-50j-72 (b) of the Regulations of Connecticut State Agencies and is hereby denied.

RE: **EM-AT&T-155A-220217** – AT&T notice of intent to modify an existing telecommunications facility located at 29 South Main Street, West Hartford, Connecticut.

Dear Ms. Davis:

The Connecticut Siting Council (Council) received a notice of intent to modify the above-referenced facility on February 17, 2022.

According to Section 16-50j-71 of the Regulations of Connecticut State Agencies, "...any modification, as defined in Section 16-50j-2a of the Regulations of Connecticut State Agencies, to an existing tower site, except as specified in Sections 16-50j-72 and 16-50j-88 of the Regulations of Connecticut State Agencies, may have a substantial adverse environmental effect."

Staff has reviewed this exempt modification request for completeness and has identified a deficiency in the Radio Frequency Emissions Analysis Report prepared by EBI Consulting, dated January 26, 2022. The Radio Frequency Analysis Report indicates a calculated, Maximum Permissible Exposure (%MPE) of 79.43 % at ground level accounting for both AT&T and Sprint antennas. The tower is located on the top of a parking garage that is accessible to the general public. Council staff calculated the power density for the proposed AT&T modification using the data provided in the report. Using the Federal Communications Commission (FCC) OET Bulletin 65 predictive methods accounting for the -10 dB off beam pattern adjustment and a 6-foot tall person at the base of the tower on the roof of the parking garage (i.e. 40 feet above ground level) results indicate that the requested modification, as proposed, would produce radio frequency emissions with a %MPE of 302.77% for each sector of AT&T's antennas and a cumulative %MPE of 331.35% with Sprint's antennas. See table attached. This exceeds the FCC's allowable General Public/Uncontrolled cumulative MPE limit of 100%.

Therefore, the exempt modification request is incomplete at this time. The Council recommends that Crown Castle provide a rigorous far-field analysis taking into account the actual antenna pattern and accounting for a 6-foot person on the roof of the parking garage with a cumulative %MPE at or below 100%, on or before April 11, 2022. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to April 11, 2022. **Please provide an electronic version of the requested information for the incomplete exempt modification to be rendered complete and processed. Please include the Council's exempt modification identification number referenced above with the submittal.**

This notice of incompletion shall have the effect of tolling the FCC 60-day timeframe in accordance with Paragraph 217 of the FCC Wireless Infrastructure Report and Order issued on October 21, 2014 (FCC 14-153).
