
Dear Ms. Gaudet:

At a meeting held on October 27, 1988, the Connecticut Siting Council acknowledged your notice of intent to modify the existing Windsor facility (Docket 58) pursuant to Section 16-50j-73 of the Regulations of State Agencies (RSA).

As proposed in your notice dated September 29, 1988, the modification is in compliance with the exception criteria for changes to an existing facility site that do not extend the boundaries of the fenced or otherwise enclosed areas of the tower site, increase noise levels at the tower site boundary by 6 decibels or more, or increase the total radio frequency electromagnetic radiation of the site boundary by more than .1 milliwatt/cm², pursuant to RSA 16-50j-72.

The Council is pleased to note that the shared use of an existing tower meets the Council's long-term goal of the public interest to avoid proliferation of additional tower structures.

Dear Mr. Rinebold:

Metro Mobile CTS of Hartford, Inc. ("Metro Mobile" or the "Company") plans to install an additional cellular antenna at its existing facility in Windsor, Connecticut. Please accept this letter as notification, pursuant to R.C.S.A. § 16-50j-73, of construction which constitutes an exempt modification pursuant to R.C.S.A. § 16-50j-72(b), and pursuant to Order No. 10 of the Council's Decision and Order in Docket No. 58.

The existing facility consists, in part, of a 160' lattice tower located at Metro Mobile's Windsor site on Pigeon Hill Road. Metro Mobile's transmit and receive antennas and a microwave dish, as well as equipment of the Town of Windsor, are currently mounted on the tower. The Company will install one additional transmit antenna, Model PD 10017, which is identical to the transmit antennas currently in place.

The height of the existing facility will be unaffected; the additional antenna will be mounted at the 158' level of the tower and will extend to approximately 173', the same height as the existing antennas. Metro Mobile's additional antenna will not increase the total radio frequency electromagnetic radiation power density measured at the tower site boundary to a level at or in excess of .1 mW/cm². The cumulative power density at the base of the tower will be 0.01803545 mW/cm², with the additional antenna contributing 0.00109803 mW/cm². There will be no increase in the noise level at the existing facility.

For the foregoing reasons, Metro Mobile respectfully submits that the addition of its antenna to the existing Windsor facility constitutes an exempt modification under R.C.S.A. § 16-50j-72(b).

Dear Mr. Rinebold:

Metro Mobile CTS of Hartford, Inc. ("Metro Mobile" or the "Company") hereby notifies the Council of the installation of antennas and related equipment at Metro Mobile's existing facility in Windsor, Connecticut, in accordance with Order No. 10 of the Council's Decision and Order in Docket No. 58. Under an agreement with the Town of Windsor (the "Town"), the Town's communications equipment will be located on and near the tower.

The existing facility is a 160' lattice tower located at Metro Mobile's Windsor facility on Pigeon Hill Road. The Town's installation consists of three UHF 7.5 dBd antennas on sidearms at the 125', 90' and the 75' levels of the tower, and one 1' 23 GHz microwave dish antenna at the 110' level of the tower. A small equipment building to house the Town's electronic equipment will be located within the fenced area at the base of the tower.

The Town's additional antennas will not increase the total radio frequency electromagnetic radiation power density measured at the tower site boundary to a level at or in excess of .1 mW/cm². The additional antennas will contribute 0.001565 mW/cm² at the base of the tower. The cumulative power density at the base of the tower will be 0.00888 mW/cm².
