Dear Mr. Gelston:

I am writing on behalf of Amtrak with reference to the telecommunications tower located within the Amtrak right-of-way in the town of Old Saybrook. Omnipoint has advised Amtrak that a Petition for a Declaratory Ruling pending before the Connecticut Siting Council ("CSC") was tabled at the CSC meeting on April 3rd, awaiting additional information, including this letter from Amtrak.

This letter is being sent at the direction of Omnipoint, which has advised Amtrak that, at the April 3rd meeting, the CSC requested a letter, from Amtrak, setting forth the following confirmation.

Amtrak confirms that, following the transfer, from Omnipoint to Amtrak, of the tower facility installed by Omnipoint on Amtrak's right-of-way in Old Saybrook, it is Amtrak's intention to continue to submit this tower to the jurisdiction of the CSC. Specifically, Amtrak will itself comply with all applicable laws, including those promulgated by the CSC, related to additional installations by Amtrak on the tower installed by Omnipoint at Old Saybrook, and Amtrak will require third-parties to comply with all applicable laws, including those promulgated by the CSC, related to this tower facility.
