Dear Dan Panicucci:

The Connecticut Siting Council (Council) received a notice of completion of construction for the above-referenced facility on November 27, 2023. Thank you for providing this information.

The Council approved the above referenced request in a Decision Letter dated January 21, 2022 (enclosed) with the following condition:

1. Within 45 days following completion of equipment installation, AT&T shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Structural Analysis for the tower structure.

The completion notice does not contain documentation certified by a Professional Engineer that AT&T's installation is in compliance with the revised Structural Analysis prepared by KM Consulting Engineers Inc., dated January 27, 2022 and stamped and signed by Michael Bohlinger.

Therefore, the completion notice is not in compliance with the conditions of approval at this time.

The Council recommends that AT&T provide the above referenced documentation on or before December 27, 2023. If additional time is needed to gather the requested information, please submit a written request for an extension of time prior to December 27, 2023.

RE: **SUBPETITION NO. 1133-CING-20211124** - New Cingular Wireless PCS, LLC (AT&T) sub-petition for a declaratory ruling for an eligible facility request for modifications to an existing telecommunications facility located at 623 Pine Street, Bridgeport, Connecticut

Dear Attorney Regan:

The Connecticut Siting Council (Council) hereby approves your Eligible Facilities Request (EFR) to install antennas and associated equipment at the above-referenced facility pursuant to the Federal Communications Commission Wireless Infrastructure Report and Order, with the following conditions:

1. Approval of any changes be delegated to Council staff;
2. Prior to AT&T's antenna installation, a passing (<100%) Structural Analysis for the proposed equipment loading certified by a Professional Engineer licensed in the State of Connecticut shall be provided to the Council;
3. Within 45 days following completion of equipment installation, AT&T shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations, if any, of the Structural Analysis for the tower structure;
4. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
5. Any nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by AT&T shall be removed within 60 days of the date the antenna ceased to function;
6. The validity of this action shall expire one year from the date of this letter; and
7. The Petitioner may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and is not applicable to any other modification or construction. All work is to be implemented as specified in the EFR dated November 23, 2021. Any changes to the eligible facility request require advance notification and approval
