RE: **SUBPETITION NO. 1133-CING-20230607** – New Cingular Wireless PCS, LLC eligible facility request for modifications to an existing telecommunications facility located at 985 Farmington Avenue, Bristol, Connecticut.

Dear Attorney Chiocchio:

The Connecticut Siting Council (Council) hereby approves your Eligible Facilities Request (EFR) to extend the existing flagpole, replace the existing concealment canister and install antennas and associated equipment at the above-referenced facility pursuant to the Federal Communications Commission Wireless Infrastructure Report and Order, with the following conditions:

1. Approval of any changes be delegated to Council staff;
2. Prior to the commencement of construction, AT&T shall provide a Structural Analysis and Construction Drawings that reference the 2022 Connecticut State Building Code and are stamped and signed by a Professional Engineer licensed in the State of Connecticut;
3. Prior to the installation of the tower extension and AT&T's antennas, the proposed Tower modifications shall be installed in accordance with the Structural Analysis prepared by GPD Engineering, dated December 1, 2021 and stamped and signed by Christopher J Schecks, or in accordance with the updated Structural Analysis referred to in Condition 2;
4. Within 45 days following completion of equipment installation, AT&T shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Structural Analysis;
5. RF access restriction and caution signage shall be installed at the site in compliance with FCC guidance;
6. Written notification to the Council at least two weeks prior to the commencement of site construction activities;
7. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable;
8. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed **along with a representative photograph of the facility**;
9. Any nonfunctioning antenna and associated antenna mounting equipment, or other equipment at this facility owned and operated by AT&T shall be removed within 60 days of the date the antenna or equipment ceased to function;
10. The validity of this action shall expire one year from the date of this letter; and
11. AT&T may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and is not applicable to any other modification or construction. All work is to be implemented as specified in the EFR dated June 6, 2023. Any changes to the eligible facility request require advance notification and approval.
