RE: **SUBPETITION NO. 1133-VER-20221020** – Cellco Partnership d/b/a Verizon Wireless eligible facility request for modifications to an existing telecommunications facility located at 71 Pleasant View Road, Derby, Connecticut.

Dear Attorney Baldwin:

The Connecticut Siting Council (Council) hereby approves your Eligible Facilities Request (EFR) to replace Verizon's existing antennas and concealment canister at the above-referenced facility pursuant to the Federal Communications Commission Wireless Infrastructure Report and Order, with the following conditions:

1. Approval of any changes be delegated to Council staff;
2. Prior to the commencement of construction, Verizon shall provide a copy of the Structural Analysis referencing the Connecticut State Building Code effective October 1, 2022;
3. Prior to the commencement of construction, Verizon shall provide a rigorous cumulative far-field radio frequency analysis for the facility that accounts for all entities on the tower, a 6-foot tall person at ground level and the actual antenna pattern for the proposed modifications to the facility with a cumulative %MPE at or below 100%;
4. If the American Flag must be removed for construction, it must be replaced consistent with the Council's Development and Management Plan Decision dated September 5, 2006;
5. RF access restriction and caution signage shall be installed at the site in compliance with FCC guidance;
6. Written notification to the Council at least two weeks prior to the commencement of site construction activities;
7. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable;
8. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
9. Any nonfunctioning antenna and associated antenna mounting equipment, or other equipment at this facility owned and operated by Verizon shall be removed within 60 days of the date the antenna or equipment ceased to function;
10. The validity of this action shall expire one year from the date of this letter; and
11. Verizon may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and is not applicable to any other modification or construction. All work is to be implemented as specified in the EFR dated October 19, 2022. Any changes to the eligible facility request require advance notification and approval.
