**RE: SUBPETITION NO. 1133-VER-20220310** – Cellco Partnership d/b/a Verizon Wireless eligible facility request for modifications to an existing telecommunications facility located at 395 Round Hill Road, Greenwich, Connecticut.

Dear Attorney Baldwin:

The Connecticut Siting Council (Council) hereby approves your Eligible Facilities Request (EFR) to replace the existing concealment radome/shroud, antennas and associated equipment at the above-referenced facility pursuant to the Federal Communications Commission Wireless Infrastructure Report and Order, with the following conditions:

1. The proposed replacement radome/shrouds shall be installed in accordance with the Mount Analysis prepared by Centerline Communications, dated November 9, 2021 and stamped and signed by Derek J. Creaser;
2. Within 45 days following completion of equipment installation, Verizon shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Mount Analysis;
3. Approval of any changes be delegated to Council staff;
4. Antennas must be internally mounted in accordance with condition No. 1 of the Council's Decision and Order in Docket No. 309;
5. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
6. Deployment of any 5G services must comply with FCC and FAA guidance relative to air navigation, as applicable;
7. Any nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by Verizon shall be removed within 60 days of the date the antenna ceased to function;
8. The validity of this action shall expire one year from the date of this letter; and
9. The Petitioner may file a request for an extension of time beyond the one year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and is not applicable to any other modification or construction. All work is to be implemented as specified in the EFR dated March 9, 2022. Any changes to the eligible facility request require advance notification and approval.
