

RE: **PE1133-CING-20200305** – New Cingular Wireless PCS, LLC (AT&T) sub-petition for a declaratory ruling for approval of an eligible facility request for modifications to an existing telecommunications facility located at 1389 West Main Street, Waterbury, Connecticut.

Dear Attorney Chiocchio:

The Connecticut Siting Council (Council) hereby approves your Eligible Facilities Request (EFR) to install antennas and associated equipment at the above-referenced facility pursuant to the Federal Communications Commission Wireless Infrastructure Report and Order, with the following conditions:

1. Prior to AT&T's equipment installation, the steel equipment platform modifications shall be installed in accordance with the Structural Analysis prepared by Hudson Design Group, LLC, last revised May 28, 2019 (Rev.1) and stamped and signed by Daniel Hamm;
2. Within 45 days following completion of equipment installation, AT&T shall provide documentation certified by a Professional Engineer that its installation complied with the recommendations of the Structural Analysis;
3. Approval of any minor changes be delegated to Council staff;
4. Within 45 days after completion of construction, the Council shall be notified in writing that construction has been completed;
5. Any nonfunctioning antenna and associated antenna mounting equipment on this facility owned and operated by AT&T shall be removed within 60 days of the date the antenna ceased to function;
6. The validity of this action shall expire one year from the date of this letter; and
7. The Petitioner may file a request for an extension of time beyond the one-year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

This decision is under the exclusive jurisdiction of the Council and is not applicable to any other modification or construction. All work is to be implemented as specified in the EFR dated March 4, 2020. Any minor changes to the eligible facility request require advance notification and approval
