RE: **PETITION NO. 1220** - Windham Solar LLC declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for the construction, maintenance and operation of three 2.0 Megawatt and one 1.0 Megawatt Solar Photovoltaic Electric Generating facilities located at 1219 and 1240 Voluntown Road, Griswold, Connecticut. **D&M Plan Revision.**

Dear Mr. Galton:

The Connecticut Siting Council (Council) is in receipt of your correspondence dated February 24, 2022 regarding the revision to the Development and Management (D&M) Plan for the above-referenced site that was approved by the Council on July 19, 2019.

Pursuant to Regulations of Connecticut State Agencies (RCSA) §16-50j-62(b), your request to install a maintenance equipment storage shed with dimensions of approximately 24-feet long by 16-feet wide by 14 feet high in the northeastern portion of the 1219 Voluntown Road site within the fenced solar array area is hereby approved.

This shed location will accommodate an electrical utility service connection. The shed will be used for the storage of items including, but not limited to, a rechargeable utility task vehicle, hand tools, stormwater maintenance equipment and appurtenances, and spare parts.

This approval applies only to the D&M Plan revision dated February 24, 2022 and additional information received on March 9, 2022. Any significant changes to the D&M Plan require advance Council notification and approval. Furthermore, the project developer is responsible for reporting requirements pursuant to RCSA §16-50j-62.

Please be advised that deviations from the standards established by the Council in the Declaratory Ruling and approved D&M Plan are enforceable under the provisions of Connecticut General Statutes § 16-50u.
