The Connecticut Light and Power Company doing business as Eversource Energy (Eversource) received approval from the Connecticut Siting Council ("Council") on March 26, 2020 (Petition No. 1293). In its March 26, 2020 letter acknowledging the above-referenced Sub-Petition, the Council included conditions regarding the work undertaken pursuant to this Sub-Petition. Eversource is requesting an extension of the deadline for completing the work activities based on the following condition:

• The petitioner may file a request for an extension of time beyond the one-year deadline provided that such request is submitted to the Council not less than 60 days prior to the expiration.

The project has experienced delays due to a number of factors and Eversource hereby requests that the one-year deadline to complete these activities be extended to March 26, 2022.
