RE: **SUB-PETITION NO. 1293-LBMW-02 (Lebanon, Bozrah, Montville and Waterford)** –
Eversource Energy declaratory ruling that no Certificate of Environmental Compatibility and
Public Need is required for all transmission facility asset condition maintenance improvements
statewide to comply with the updated National Electrical Safety Code clearance requirements.

Dear Mr. Alexander:

The Connecticut Siting Council (Council) is in receipt of the Town of Bozrah's Request for an Extension of Time to submit written comments concerning Eversource Energy's (Eversource) above-referenced request for approval to replace 46 existing electric transmission line structures to comply with the updated National Electrical Safety Code (NESC) standards on an existing electric transmission line that traverses the municipality of Bozrah.

The Council established a 30-day period from the date notice of the sub-petition is provided to the town and abutting property owners for the submission of any comments or concerns about the project. The current deadline date for comments on this sub-petition is September 26, 2021.

The Council hereby grants the Town of Bozrah's Request for an Extension of Time to submit written comments on the above-referenced sub-petition to October 18, 2021.

The NESC is the authoritative code for ensuring the continued practical safeguarding of persons and utility facilities during the installation, operation and maintenance of electric power and communications utility systems, including substations, overhead lines and underground lines. Compliance with the NESC standards requires Eversource to evaluate the integrity of its utility structures and implement repair, upgrade or replacement in order to ensure the safe and reliable transmission of electric power to its customers. Due to compromised asset conditions, utility structures exhibiting age, weathering, cracking, splitting, rot and woodpecker holes must be replaced to comply with the NESC.

In reaching a final decision on a request under Petition No. 1293, the Council carefully considers whether the request complies with the NESC standards. Please be advised that the Council's jurisdiction extends only over the four structure replacements requiring an increase in height to comply with the NESC that are referenced in this sub-petition. Structure replacements that do not require an increase in height to comply with the NESC are not subject to the Council's jurisdiction.
