RE: **SUB-PETITION NO. 1293- MCCL-01 (Mansfield, Coventry, Columbia, and Lebanon)** – Eversource Energy declaratory ruling that no Certificate of Environmental Compatibility and Public Need is required for all transmission facility asset condition maintenance improvements statewide to comply with the updated National Electrical Safety Code clearance requirements.

Dear Ms. Taylor:

The Connecticut Siting Council (Council) is in receipt of your correspondence dated October 16, 2020 regarding a project change to the Petition No. 1293 sub-petition for the above-referenced section of transmission line that was approved by the Council on June 22, 2020.

The proposed project change consists of the use of an existing gravel access drive previously installed by the underlying property owner to avoid a shared driveway located within Eversource's existing right-of-way to access structures #6536A and #6536B in Columbia. The request was made by the underlying property owner to avoid potential impacts to the shared driveway and abutting properties. The revised access would extend between existing structures #10719 and #6535 within the right-of-way. No environmental impacts are associated with the revised access route.

Pursuant to the Council's Petition No. 1293 decision of March 31, 2017 and the June 22, 2020 decision on this sub-petition, your request for the proposed modifications is hereby approved. This approval applies only to the project changes dated October 16, 2020. Any additional changes to the sub-petition decision require advance notification and approval.

Access Road Change to Structures 6536 A/B**

Dear Ms. Bachman:

On June 22, 2020, the Connecticut Siting Council (Council) determined that the subject Sub-Petition would not have an adverse environmental effect and would not require a Certificate of Environmental Compatibility and Public Need. The Connecticut Light and Power Company doing business as Eversource Energy (Eversource) submits to Council staff for review and approval a proposed change regarding a minor shift of an access road between Structures 6535 and 6536, which was previously submitted to and approved by the Council.

Since the time of the Council's determination, the property owners (LL#s 190, 192, 194, and 189) requested Eversource to use a separate existing gravel access road, installed by the owners, to access Structures 6536 A/B. The alternative existing access would avoid impacting the property owners shared maintained paved driveway, located within Eversource's existing right-of-way and east of the suggested alternate access road. As a result of this property owner's request, Eversource proposes to use the alternative access road. There would be no impacts to wetlands. (See the revised Attachment A: Map 14 of 17)

Eversource has briefed Town of Columbia representatives regarding the Project modifications and has notified the abutting property owners.
