I. Introduction:

In accordance with Condition 1 of the March 30, 2017 ruling by the Connecticut Siting Council (the "Council") (as set forth in the Council's March 31, 2017 letter) regarding Petition No. 1293, The Connecticut Light and Power Company doing business as Eversource Energy ("Eversource") submits this Sub-Petition.

II. Description of Transmission Work Activities:

Eversource's 3424/1767 Transmission Lines Structure Replacement Project is part of an ongoing maintenance program which evaluates the integrity of its utility structures and implements repair, upgrade or replacement in order to ensure the safe and reliable transmission of power to its customers. Due to asset condition, 28 structures require replacement on the 3424/1767 Lines between Manchester Substation in Manchester and a location just southeast of Portland Cobalt Road in Portland. The 3424 Line in its entirety, is a 345-kilovolt ("kV") line that extends from the Kleen Energy Generation Station in Middletown to Manchester Substation. The 1767 Line, in its entirety, is a 115-kV line that extends from Hopewell Substation in Glastonbury to Manchester Substation. The structures to be replaced are a mix of wood H-frame structures and wood single-pole structures. Of the structures to be replaced, 28 will require an increase in structure height to comply with current clearance requirements.

Eversource plans to conduct transmission structure replacement work to remediate damage caused by structure age, weather, and woodpecker activity. The following work ("Work Activities") will be performed:

- Replace 28 existing wood structures with new weathering steel structures. Each replacement structure will be of the same design as its corresponding existing structure.

III. No Substantial Adverse Environmental Effect:

Eversource respectfully submits that the proposed modifications would have no "substantial adverse environmental effect" pursuant to Conn. Gen. Stat. § 16-50k, based on the following factors:

- a) All Work Activities would take place in areas within Eversource's property and existing right-of-way ("ROW") utilizing existing and proposed new permanent access roads, as well as some temporary access roads (collectively the "Work Areas"). Some of the existing access roads would be improved. Eversource can access each of the structure replacement locations utilizing its existing rights.
- b) Collectively, utilizing existing and temporary access roads, the Work Activities would result in approximately 48,335 square feet ("SF") of temporary wetland impacts from the temporary use of construction matting required for the construction of access roads to and work pads for structures as follows:

Work would be conducted in accordance with Eversource's *Best Management Practices Manual for Massachusetts and Connecticut (Construction and Maintenance Environmental Requirements)*, September 2016 ("BMPs") to avoid impacts to nearby wetland and watercourse resources.

- c) No adverse impacts to vernal pools are anticipated from the proposed Work Activities. However, one Confirmed Vernal Pool ("CVP") habitat has been identified ("CVP-1") near a portion of the existing access road between Structures 9115 and 12181. The access road is located within the Vernal Pool Envelope ("VPE") associated with CVP-1. Vernal pool species protection measures will be implemented where Work Activities extend into the VPE. The existing access is established and would not be widened or altered and vegetation removal would be limited to hand clearing only. With the implementation of these protective measures, no adverse impacts to CVP-1 or the VPE are anticipated from proposed Work Activities.
- d) Based on review of the Connecticut Department of Energy and Environmental Protection's ("CTDEEP") Natural Diversity Database ("NDDB"), the Work Activities associated with the access roads and work pads for Structures 12156, 12152, 12145, and 12118 are proposed

within a NDDDB buffered area and are subject to a NDDDB review request. Eversource is currently in consultation with CTDEEP regarding Eversource's proposed work in these areas and will adhere to any state-listed species protection measures recommended by CTDEEP, as necessary. Any recommended measures will be incorporated into the BMPs during construction. With these protective measures, no adverse impacts to state-listed rare species are anticipated.

- e) The Work Activities will not require any tree clearing. However, Eversource may need to undertake tree trimming and/or vegetation removal/mowing to establish required conductor clearance, to improve access roads and/or to install work pads within the Work Areas.
- f) A Phase 1A assessment review of previously recorded cultural resources on file with the Connecticut State Historic Preservation Office conducted by Heritage Consultants, LLC ("Heritage") did not identify any National Register of Historic Places properties/districts or archeological sites within 500 feet of the Work Areas. However, one historic home identified as the W.H. Bunce House is situated approximately 125 feet west of Structure 12227 and one prehistoric site known as the Multi-Use Path Transect 1 site is present approximately 450 feet southwest of Structure 9141. The home is a State registered Historic Places Property and is characterized as a Federal style home constructed in 1820 by Alpheus Quincy, an African American stonemason. The prehistoric site is interpreted as a short-term camp associated with hunting and foraging near wetlands. The historic structure and the prehistoric site will not be affected by the proposed Work Activities at Structure 12227 due to the like-for-like design, modest height increase of 4.5 feet and distance from the Work Area to the historical structure. Further, after review of historic data, soil profiles, and a pedestrian survey, none of the proposed work areas possess a potential for moderate to high archeological sensitivity. Therefore, the Project is not expected to have an effect on cultural resources.
- g) Increases in heights of the 28 replacement structures will average approximately 7 feet and none of the increases will exceed 10 feet.
- h) Twenty-five of the replacement structures would be installed within 15 feet or less of the existing structure locations. However, Structure 12230 is currently located inside Manchester Substation along the substation fence near an underground gas line and will be repositioned 20 feet outside of the substation to allow room for constructability and provide clearance from the gas line and the substation security fence/fence footings. Structures 12128 and 12131 will be repositioned 20 feet and 30 feet, respectively, from the existing structures to maintain required clearance distances.
- i) Work activities associated with the replacement of Structure 12227 are located partially within the 100-year flood zone associated with the South Fork of the Hockanum River. Work activities associated with Structure 12130 are located partially within the 100-year flood zone associated with Carr Brook. Eversource would utilize the BMPs to minimize any impacts to the flood zones by utilizing temporary construction matting and/or by not placing fill that would increase the elevations of the proposed access road surfaces or work pads to ensure that the floodplain hydrology would not be adversely affected. With these protective measures and the use of the BMPs, no adverse impacts to the 100-year flood zones are anticipated from the proposed Work Activities.
- j) No change in noise levels would result from the installation of the new structures and the applicable line would continue to comply with the State of Connecticut noise regulations.

k) Any changes in electric and magnetic field levels outside the ROW would be negligible.

#### IV. Mitigation:

Temporary environmental effects from construction will be mitigated as follows:

- Erosion and sediment ("E&S") controls will be employed and maintained, as needed, for the duration of the Work Activities in accordance with the 2002 Connecticut Guidelines for Soil Erosion and Sediment Control and the BMPs.
- Potential impacts to wetlands and watercourses will be mitigated with the use of temporary matting and adherence to the BMPs.
- Vernal pool protective measures will be incorporated into the BMPs during construction.
- Any NDDDB recommended rare species protective measures will be incorporated into the BMPs during construction.
- Potential impacts to the 100-year flood zones would be avoided with adherence to the BMPs and the use of temporary construction matting.
- Eversource's contractor will perform construction sequencing such that any earth materials are exposed for a minimum amount of time before they are covered, seeded, or otherwise stabilized to prevent erosion.
- During construction, when necessary, anti-tracking mats would be installed at construction entrances to public roads to prevent tracking of soil onto local roads.
- Upon completion of the Work Activities, all disturbed/exposed areas will be stabilized and revegetated as needed. After establishing permanent ground cover, Eversource's contractor would remove the temporary E&S controls and remove/dispose of any accumulated sediments and debris from areas where such measures were used.

V. Access:

Some new permanent access roads would be constructed in upland areas to facilitate access to structures on Eversource property and/or within the ROW. Existing access roads in upland areas may be hardened and widened at turning areas to facilitate the safe passage of construction vehicles. Construction matting will be used for temporary access roads within wetlands. The matting will be removed upon completion of the Work Activities and the areas restored, as necessary.

Eversource will access the Work Areas by entering its ROW from existing access points on public roads as follows:

Manchester

- Olcott Street for structure 9185.
- West Center Street for structure 12230.
- Bidwell Street for structures 12227 and 12226.
- Wetherell Street for structures 12223, 12219 and 12218.
- Bush Hill Road for structures 12215 and 9141.


Glastonbury

- Neipsic Road for structure 12186.
- New London Turnpike for structures 9115, 12181 and 12179.
- Chestnut Hill Road for structure 12174.
- Coldbrook Road for structure 12170.
- Clark Hill Road for structures 12156, 12154 and 12152.

Portland

- East Cotton Hill Road for structures 12145 and 12141
- Old Marlborough Turnpike for structures 12133, 12132, 12131 and 12130.
- Penfield Hill Road for structure 12128.
- Collins Hill Road for structure 12118.
- Portland-Cobalt Road for structure 12109.
- Sand Hill Road for Structure 12108.

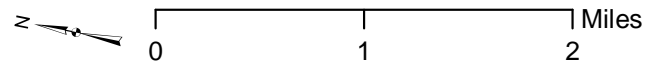
