
The Connecticut Light and Power Company dba Eversource Energy ("Eversource") received acknowledgement from the Connecticut Siting Council ("Council") on November 5, 2021 to its Notice that Eversource's proposed modifications on the 387 and 3041 Line in the Town of Middlefield would comply with the exception criteria outlined in Section 16-50j-57(a) of the Regulations of Connecticut State Agencies. In its acknowledgement, the Council included conditions regarding the proposed work, including the following:

- The Requestor may file a request for an extension of time beyond the one-year deadline, provided that such request is submitted to the Council not less than 45 days prior to the expiration.

Due to delays in final engineering and development of a constructability plan, the Project requires additional time to complete. Eversource has engineering concerns in this Right of Way zone and would like to extend the current Sub-Petition while we vet the challenges and prepare an amendment for a final solution. Eversource hereby requests that the one-year deadline to complete the Project be extended to November, 2023.
