Structure Location: 121 Transmission Structures located in Preston, Lisbon, Canterbury, Plainfield and Brooklyn, Connecticut

I. Introduction:

In accordance with Condition 1 of the March 30, 2017 ruling by the Connecticut Siting Council (the "Council") (as set forth in the Council's March 31, 2017 letter) regarding Petition No. 1293, The Connecticut Light and Power Company doing business as Eversource Energy ("Eversource") submits this Sub-Petition.

II. Description of Transmission Work Activities:

Eversource's 1607/1505 Transmission Line Structure Replacement Project is part of an ongoing maintenance program, which evaluates the integrity of its utility structures and implements repair, upgrade or replacement in order to ensure the safe and reliable transmission of power to its customers. Due to asset condition, many structures require replacement on a portion of the 1607/1505 Line between Tunnel Substation in Preston and the Day Street Junction in Brooklyn, Connecticut. The 1607/1505 Line in its entirety, is a 115-kV transmission line that extends from Tunnel Substation in Preston to Killingly Substation in Killingly, Connecticut. Of these replacements, 121 structures require a slight increase in structure height to comply with current clearance requirements.

Eversource plans to conduct transmission structure replacement work to remediate wood structure damage caused by structure age, weather, and woodpecker activity. The following work ("Work Activities") will be performed:

- Replace 121 existing wood structures with new weathering steel structures of the same design that are slightly taller (10 feet or less) than the existing structures. The replacement structures will be installed within 15 feet of the existing structures.

III. No Substantial Adverse Environmental Effect:

Eversource respectfully submits that the proposed modifications would have no "substantial adverse environmental effect" pursuant to Conn. Gen. Stat. § 16-50k, based on the following factors:

- a) Work Activities would take place in areas within Eversource's property and existing right-of-way ("ROW") utilizing existing and proposed new access roads as well as some temporary access roads

(collectively the "Work Areas"). Some of the existing access roads will be improved. Eversource can access the structure locations utilizing its existing rights, but is currently working with private landowners to obtain rights to utilize alternative off-ROW access routes that would minimize the amount of proposed access roads that would need to be installed within the ROW. In some areas, alternative off-ROW access routes would lessen the impact to wetlands and/or residential/agricultural areas.

- b) Work Activities would result in $\pm 77,400$ square feet ("SF") of temporary wetland impacts limited to temporary construction matting required for the construction of access roads to structures 7145, 7151/7151A, 7152, 7173, 7207, 7209, 7287/7287A, 7289, 7300, 7305, 7306, 7307, and 7308 and work pads for structures 7151/7151A, 7158, 7209, 7284, 7289, 7296, 7298, 7299, 7300, 7305, 7306, 7307, and 7308. Work Activities would also result in $\pm 4,700$ SF of temporary watercourse impact for a temporary matted span for the access road to structures 7151 and 7151A. See Table below for details.

Work would be conducted in accordance with Eversource's *Best Management Practices Manual for Massachusetts and Connecticut (Construction and Maintenance Environmental Requirements)*, September 2016 ("BMPs") to avoid impact to nearby wetland and watercourse resources.

- c) No vernal pools are located in proximity to the Work Activities.
- d) As a result of Eversource's review of the Connecticut Department of Energy and Environmental Protection's ("CTDEEP") Natural Diversity Data Base ("NDDDB"), only Work Activities associated with access to structures 7207 and 7209 and a portion of the work pad associated with structure 7209 are proposed within a NDDDB buffered area and wetland jurisdictional area and therefore would be subject to a NDDDB review request. In addition, the work pad for structure 7257 is located within a NDDDB buffered area and within state-owned CTDEEP property and accordingly would be subject to a NDDDB review request. Eversource is currently in consultation with CTDEEP regarding its proposed work in these areas and will adhere to any state-listed species protection measures recommended by CTDEEP, as necessary, and which will be incorporated into the Company's BMPs during construction. With these protection measures, no adverse impacts to state-listed rare species are anticipated.
- e) The structure replacements will not require any tree clearing. However, Eversource may need to undertake minor tree trimming and/or vegetation removal/mowing within the managed ROW corridor to improve access to portions of the Work Areas.
- f) A Phase IA assessment review of previously recorded cultural resources on file with the Connecticut State Historic Preservation Office conducted by Heritage Consultants, LLC ("Heritage") did not identify that any National or State Register of Historic Places properties/districts are located within 500 feet of the Work Areas. Based on a review of historic maps, aerial photographs and available soil profiles, 59 of the proposed work pad locations were identified to possess a potential for moderate to high archaeological sensitivity. These locations were evaluated in the field with a pedestrian survey by Heritage and 36 of them were found to have steep slopes, large bedrock formations, previous disturbance, or previously installed gravel pads. They were reclassified as no or low sensitivity areas, concluding that no additional archaeological examination of these areas is warranted. A Phase 1B cultural reconnaissance survey (shovel pit testing) was performed at the remaining 23 structure locations. Two prehistoric lithic flakes were recovered near Structure 7125, however, no additional artifacts or evidence of cultural features were identified. Therefore, no additional examination is recommended. No cultural resources were identified at the other 22 structures, and therefore, no further cultural investigation is warranted, and no protective measures are required.
- g) Increases in the heights of the 121 replacement structures average approximately 5 feet and none will exceed 10 feet.
- h) Replacement structures would be located within 15 feet of existing structures.
- i) With the exception of an access road to structure 7209 and work pads for structures 7209 and 7257, which are located in a 100-year flood zone associated with the Quinebaug River, and the access roads and work pads for structures 7296, 7298, 7299, 7300, 7305, 7306, 7307, and 7308, which are located in a 100-year flood zone associated with Long Brook, there are no 100-year flood zones in the Work Areas. No work will occur within the mapped 100-year flood zones except for the use of temporary construction matting. Eversource would utilize its BMPs to minimize any impacts to the flood zones associated with the access roads by not placing fill that would increase the elevations of the road surface to ensure that the floodplain hydrology is not adversely affected. Therefore, no adverse impact to the 100-year flood zone will result from the proposed Work Activities.
- j) No change in noise levels would result from installation of the new structures and the line would continue to comply with the State of Connecticut noise regulations.

- k) Any changes in electric and magnetic field levels outside of the ROW would be negligible.

IV. Mitigation:

Temporary environmental effects from construction will be mitigated as follows:

- Erosion and sediment controls ("E&S") will be employed and maintained, as needed, throughout the execution of the Work Activities in accordance with the 2002 Connecticut Guidelines for Soil Erosion and Sediment Control and the BMPs.
- Potential impacts to wetlands will be mitigated with the use of temporary matting and adherence to the BMPs.
- NDDDB recommended rare species protection measures will be incorporated into the Company's BMPs during construction.
- Potential impacts to 100-year flood zones associated with the Quinebaug River and Long Brook would be avoided with adherence to the BMPs and the use of temporary construction matting.
- Eversource's contractor would perform construction sequencing such that any earth materials are exposed for a minimum of time before they are covered, seeded, or otherwise stabilized to prevent erosion.
- During construction, when necessary, anti-tracking mats would be installed at construction entrances onto public roads to prevent tracking of soil onto local streets.
- Upon completion of the Work Activities, all disturbed/exposed areas would be stabilized and revegetated. After the establishment of permanent ground cover, Eversource's contractor would remove the temporary E&S controls and remove/dispose of any accumulated sediments and debris from areas where such measures were used.

V. Access:


Some new permanent access roads would be constructed to facilitate access to structures within the ROW and existing access roads may be hardened and temporarily widened at turning areas to facilitate the safe passage of construction vehicles. Construction matting would be used on temporary access roads in wetlands as well as in agricultural/maintained lawn upland areas. The matting will be removed upon completion of the Work Activities and the areas restored, as necessary.

Eversource would access the Work Areas by entering its ROW from existing access points on public roads as follows:

- Roosevelt Avenue for structures 7121, 7121A, 7122, 7124, and 7124A
- River Road for structures 7125 and 7125A
- Bundy Hill Road for structures 7135, 7136, 7137, 7140, 7140A, and 7143
- Mell Road for structures 7144, 7145, 7148, 7148A, 7149, 7150, 7151, 7151A, and 7152
- Newent Road for structures 7157, 7157A, 7158, and 7159
- Bushnell Road and Ross Hill Road for structures 7171, 7172, 7173, and 7174
- Ross Hill Road for structures 7177 and 7178

- Phillips Road via Pleasant View Cove Road, (a private road), for structures 7177 and 7178, 7183, 7186, 7187, and 7189
- Depot Road for structures 7190, 7190A, 7195, 7195A, 7196, and 7197
- Shagbark Lane for structure 7192
- Butts Bridge Road for structures 7198, 7199, and 7203
- Packer Road for structures 7204, 7204A, 7206, 7207, 7209, 7210, and 7211
- Weston Road for structures 7213, 7214, 7214A, 7215, 7216, 7217, 7217A, 7218, 7219, 7221, 7221A, and 7222 (off-ROW access from an alternative location on Weston Road would also be used if rights are obtained)
- Canterbury Road for structures 7227, 7229, and 7230
- Exley Road for structures 7232 and 7234, and 7234A
- Black Hill Road for structures 7239, 7239A, 7241, 7242, and 7242A
- Sugar Brook Road for structures 7243
- Sugar Brook Road and Black Hill Road for 7244, 7245, 7246, 7252, 7253, and 7254
- Maynard Road for structures 7257, 7258, 7259, 7260, 7262, and 7262A
- Christian Hill Road for structures 7265, 7266, and 7267
- Wauregan Road for structures 7268, 7269, 7269A, 7270, and 7271
- River Walk Drive and South Street for structures 7273, 7280, 7280A, 7281, 7282, 7284, 7286, 7287, 7287A, and 7289 (to avoid agricultural property, off-ROW access may be used for structure 7273 if rights are obtained)
- South Street for structure 7292
- Allen Hill Road for structure 7294
- Providence Road for structure 7296
- Brickyard Road for structures 7298 and 7299
- Day Street for structures 7300, 7303, 7304, 7305, 7306, 7307, 7308, and 7312

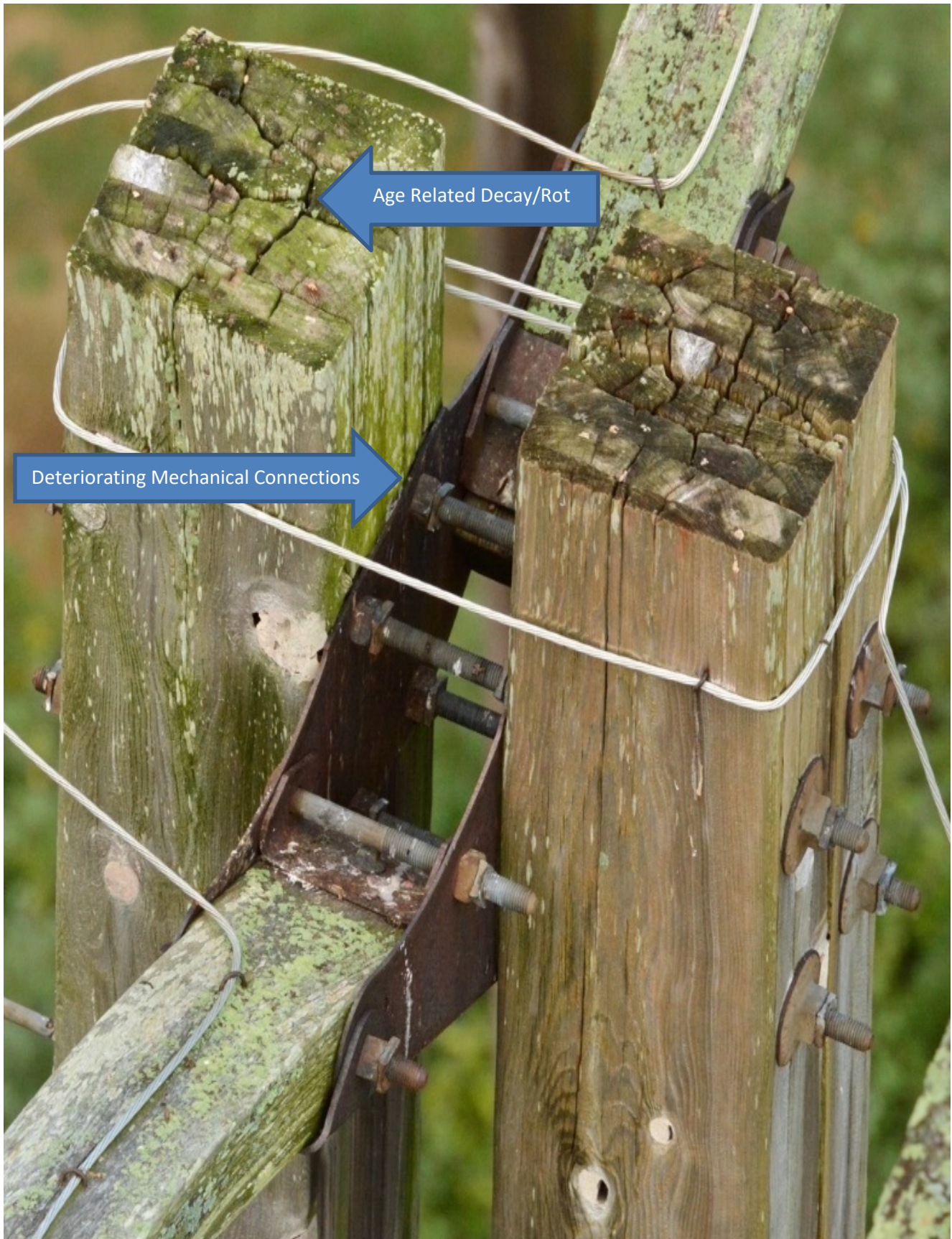

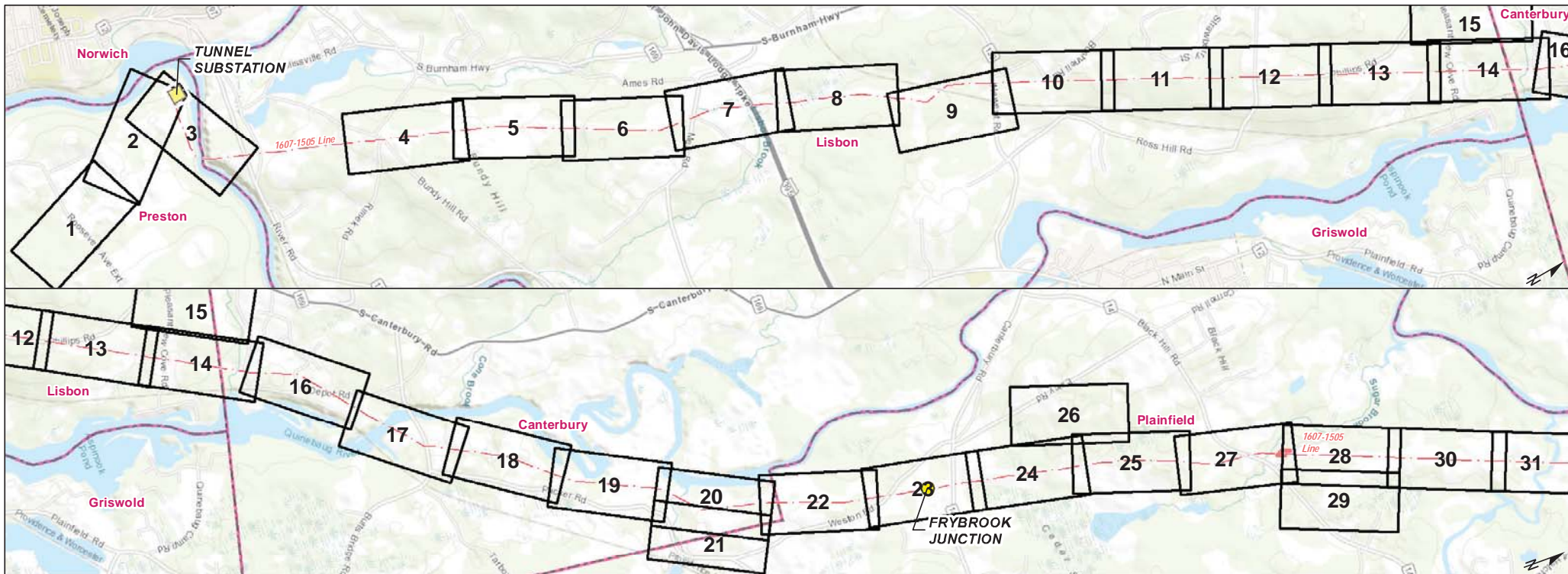

As part of our everyday effort to deliver reliable energy to our customers and communities, we're planning work in your area to replace electric transmission structures. Maintaining the infrastructure that supports the electric lines is one of the ways Eversource ensures the safe, secure transmission of electricity throughout the region.

You're receiving this letter and a copy of the Sub-Petition because the proposed work would be taking place within the right of way on or near your property in Preston, Lisbon, Canterbury, Plainfield and Brooklyn. A Sub-Petition is a document with detailed information about the proposed upgrades. Eversource is submitting Sub-Petition No. 1293-PLCPB-01 this week to the Connecticut Siting Council (CSC) for its review and approval.

About This Electric System Improvement: What You Can Expect

First, we want you to know that this work will not interrupt electric service to your property.

As part of this project, we are proposing to replace, and slightly increase the height of the existing wood structures. The new, weathering steel structures will increase in height by 9 feet or less, depending on the location.

We are proposing to do the work within the existing rights of way on or near your property. The new structures will provide continued reliability of the transmission system.


