

Re: Notice of Amended Project Name

Dear Executive Director Bachman,

Please note the following with respect to Pawcatuck Solar Center, LLC, petitioner in Petition No. 1345, a 15 MW AC solar photovoltaic electric generating facility on approximately 353 acres east of Pendleton Hill Road, north of the Pawcatuck Rier and south of I-95.

- A change of control of the project has occurred. On May 1, 2019, Lincoln Clean Energy, a subsidiary of Ørsted, acquired Developer and all of its rights, title, interests, and obligations under the Option Agreement. Additionally, the development staff previously working on the project are now employees of LCE and continue to work on the project.
- 2) The Project name has been changed as of May 16, 2019 through a filing with the Secretary of the State of Connecticut, changing "Pawcatuck Solar Center, LLC" to "North Stonington Solar Center, LLC". This is not an assignment of the project company but a change of the name of the same tax entity.
