RE: Petition No. 1347A – GRE GACRUX LLC petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a 16.78-megawatt AC solar photovoltaic electric generating facility located at 117 Oil Mill Road and associated electrical interconnection to Eversource Energy's existing substation at 325 Waterford Parkway North in Waterford, Connecticut. Reopening of this petition based on changed conditions pursuant to Connecticut General Statutes §4-181a(b).

I am writing on behalf of my client, GRE GACRUX LLC (hereinafter, "Greenskies") in connection with the above-referenced Petition. Pursuant to the Council's Decision and Order, dated November 5, 2020, in the above-referenced Petition, Greenskies respectfully submits the following Development and Management Plan ("D&M") documents to the Council for its review and approval. This submission is a partial D&M Plan submission for the Project.

The documents included with this cover letter only pertain to the "Pre-Construction Sequence Work" that is outlined on Page C 5.0 of the Construction Drawing Set. The goal with this submission is to allow Greenskies to do necessary civil work and construction of stormwater controls on the site, but not to begin driving posts or installing racking, panels or other equipment. Before that phase of construction will be undertaken, Greenskies will submit a further D&M Plan that will address that stage of construction, in accordance with the Council's Decision and Order.

The items listed below are included in this Partial D&M Plan Submission:

1. A Partial D&M Plan for the Pre-Construction Sequence Work, which includes:
