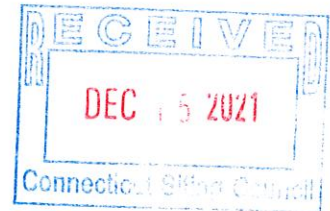

Dear Executive Director Bachman:

On behalf of Sprint Spectrum Realty Company, LLC (“Sprint”) and T-Mobile Northeast LLC (“T-Mobile”), we respectfully request a one (1) year extension of time to March 15, 2023 to operate the Temporary Facility approved in connection with the above-captioned matter.

As the Council is aware, the Temporary Facility is located at an office building campus at 201 High Ridge Road in Stamford and is maintaining continuity of T-Mobile’s wireless services while a new building is constructed, which will host T-Mobile’s replacement and permanent rooftop facility.

At this time, the new building has been erected and construction is nearing completion. T-Mobile anticipates its permanent rooftop wireless facility will be constructed and operational in late 2022. We are requesting a one (1) year extension of time to accommodate the completion of building construction and installation of T-Mobile’s permanent rooftop facility.

This request is being timely made in accordance with Condition 6 of the Council’s February 15, 2019 Decision & Order.
