

RE: **PETITION NO. 1387** – Bloom Energy Corporation petition for a declaratory ruling, pursuant to Connecticut General Statutes §4-176 and §16-50k, for the proposed construction, maintenance and operation of a grid-side 10-megawatt (MW) fuel cell facility and associated equipment to be located at Eversource Energy's existing Judd Brook electric distribution substation, 160 Old Amston Road, Colchester, Connecticut. In response to the March 12, 2020 letter requesting a deadline extension for the Development and Management (D&M) Plan review. Bloom Energy respectfully requests that the approval, request for modification or disapproval of the D&M Plan occur at the Connecticut Siting Council staff level. The D&M Plan has been reviewed and Bloom has addressed and/or modified the plan in its March 11 correspondence with Siting Council. In addition, CTDEEP has provided the attached approval letter for the Stormwater Pollution Control and Prevention plan and the Town of Colchester has issued a building permit and approved the water main extension for the project. Bloom Energy is endeavoring to maintain commitments to Eversource and United Illuminating to export power in response to part of a 2018 CT DEEP RFP that was designed to provide clean, reliable and low-cost energy solutions to Connecticut's utility customers. In the spirit of resiliency and adapting to the evolving COVID-19 situation, please consider allowing work to commence following a staff level review process of the Development and Management Plan.
